



# Resident Application for Apprentice Class Falconer Certificate of Registration (COR)

**New applicant:** Before applying for the first time, you must have passed the required falconry exam. Please contact [falconry@utah.gov](mailto:falconry@utah.gov) or visit our webpage <https://wildlife.utah.gov/hunting/main-hunting-page/falconry.html> for specific information on becoming an apprentice falconer. . If you are transferring as an Apprentice from another state upon completion of the residency requirement, you must submit a copy of a valid falconry license from the former state of residency indicating class and a valid federal falconry permit.

**Renewal applicant:** If you are an Apprentice and want to renew your COR as an Apprentice submit application by the expiration date specified on your current COR. This will allow you to maintain raptors in possession without being in violation of unlawful captivity of protected wildlife. If you have not held a Falconry Certificate of Registration for two consecutive years re-examination and facilities inspection are required and you must have authorization from the falconry coordinator that these requirements are met.

All payments received by mail are processed in 3 business days but if the applicant does not qualify, the fee will be refunded.

**An apprentice class falconer whether new or renewing is required to have a sponsor by a general or master class.**
