Then I saw the article today about how instead of 376,000 deer across the state, there are only 275,000 deer, which is what I thought it was. This is the poorest the herd has ever been. We have been told year after year by the DWR that there are more deer than there ever has been but the people actually out in the field, the hunters, have been saying for years that the deer population is down more than it has ever been. So about 5 years too late, its finally admitted that there are 100,000 less deer on the landscape however, we keep increasing tags. There is an easy solution to rebound the deer faster than anything. Stop increasing tags. I know that money needs to be generated from somewhere. I understand that. Increase the general tag price from \$40 to \$60 and cut the tags by 1/3. I don't really agree with antler point restrictions but allowing youth to take any buck i feel like is a great compromise, I actually don't agree with any of the restricted weapons proposals except maybe the archery ones (and I'm an archery hunter) i still want a chance to use a compound bow on the unit going to restricted archery (maybe just a 90:10 split, the 10 going to compound) but who has a muzzleloader that meets these requirements? I don't even think you can buy one that meets those restrictions, same with rifle they don't come with open sights anymore, I really hate to say this but I fully believe shorter season dates is the best thing for deer hunting, less pressure on animals should allow for better body conditions which can allow for better winter survival as well as potentially better antler growth in bucks (I still like the season dates we have now) maybe take 2 days from rifle, keep muzzleloader the same and knock archery down by a week may be a good compromise. Back to the resticive weapons though I really feel that even if it helps i really feel as though we have a good balance with the weapons we have now and if it will help just splitting the tags 70:30 (70 for current weapons and 30 for primitive) at the most to still give people an option for the weapon they want to use while still giving some people the opportunity for an easier tag to draw with much harder success rates if that's what they want

I have been been in the Dedicated Hunter program since its inception. I have hunted the same area in the Cache Unit for over 46 years. I have been extremely satisfied with deer hunting. Last year hunters were required to pull magnifying scopes off of muzzleloaders. This change cost \$500 for a new sight system. Under this new proposal I will have to scrap my current muzzleloader and invest \$500 to \$600 for a muzzleloader that fits the restricted muzzleloader definition.

We will also be required to remove our scopes off our rifles. "If only our rifles had iron sights", so back to the store to purchase a rifle with iron sights. Another six to nine hundred dollars. This research study could cost each hunter a minimum of \$1,200 if they are in the Dedicated Hunter program or \$500 to \$900 if they draw muzzleloader or rifle tag.

The Cache unit currently has around 200 Dedicated Hunters. Each hunter completes 32 hours or they buy their hours at \$40 per hour. If half of the dedicated hunters drop out due to the new equipment requirements, it could be a loss of 3,200 volunteer hours. Will other sportsman's organizations step up to complete the volunteer hours? Will habitat projects on the Cache unit not be completed?

What is the purpose of this proposal? Is it to increase the number of licenses sales or is it to increase the number of bucks?

The Cache unit currently has 17 bucks per 100 doe's post season. Objective is 15 to17 bucks per 100 doe's post season. The Cache unit is very weather dependent. When we have a hard winter we lose our deer. If we have more bucks than objective, it takes longer for the deer herds to rebound from winter loss. The bucks out-compete the doe's for survival, reducing the reproduction and survival of fawns.

Next year I will be 62 and my eyesight is declining. I depend on a scope to insure I make a humane harvest. Open sights including a peep sight with a globe front sight has made precision shot almost guess work. I can't imagine a new hunter using open sights when the hunter education course allows them to use scopes to pass their shooting proficiency test.

Lets wait until the data is collected from this years hunt before significant changes are made impacting the 4,000 plus hunters that hunt the Cache unit.

This proposal doesn't do anything for habitat that will sustain deer numbers.

I support these forward thinking game management strategies and am excited for what we would learn. Here is my personal feedback on each strategy:

Restricted Weapons hunts: I believe the restricted weapons hunts are the most promising and exciting strategy that is being proposed. Restricted or "traditional" weapons are the most practical way for Utah to offer increased hunting opportunity, while simultaneously increasing hunt quality. Hunting opportunity and quality are the two things that hunters demand the most, but beyond that, hunting with traditional weapons also increases the value that hunting holds for the non-hunting majority. The majority of Americans that do not hunt still believe that it is important to preserve hunting traditions because hunting is an inarguably important part of our human heritage. However the majority of non-hunting Americans do NOT support killing animals with advanced technology or hunting for trophies or "sport". If hunting opportunities are to continue long into the future, I believe it will be absolutely necessary to adjust our game management strategies in such a way that it is absolutely clear that we are genuinely preserving hunting traditions. Traditional Archery is the most globally recognized and deeply rooted hunting method and should be incentivised in game management, so It is exciting to see it being used as a specific game management tool for the first time. In Utah we have the constitutional "right to use traditional methods to hunt" in order to "preserve the future of hunting" and I like to see our game management strategies adjusting to stay more in-line with our constitution and making a genuine effort to preserve our hunting traditions.

Antler point restrictions: Knee jerk reaction is that I do not like the idea of being "required" to trophy hunt. It seems like it would be very difficult to regulate especially with the requirement being only for adults but not youth. I am still open to this strategy and think it might be worth trying.

I am completely in favor of growing deer and support measures do so, including more aggressive predator control measures. I feel this is a major contributing factor to being able to grow more deer.

I have some serious reservations for increasing tags by about 20,000 overall.

I am disappointed in the plan of reducing Buck to Doe ratios from 18-20 to 15-17, it really is an attempt to create more revenue by increasing opportunity about 20,000 tags or about a \$1,000,000 at the expense of sportsmen, I really do not like this and feel it is inappropriate especially where many of the units that will be reduce don't seem to have health issues.

I have a major concern with your science and recommendation proposal. It is emphasized that for health reasons, we need 15-17 Buck to Doe ratios, however they want to keep 18-20 Buck to Doe is some units. According to your presentation and data, 4 of the 11 units that are to remain 18-20 Buck to Doe have confirmed cases of CWD. This is a conflicting argument, and there are several underlying factors as to why the DNR is willing to allow higher Buck to Doe ratios here. I would like a lot more transparency as to the reasoning to keep higher ratios in these units (with CWD) rather than lower them and increase others without CWD. It is concerning the number of units that have been reduced from 18-20 to 15-17 since 2018, at least seven units have been reduce for more opportunity according to the 2019 plan all but one of these units were in the southern portion of the State. Additionally in the proposal it states that "the lower buck-to-doe ratio objective was designed to provide for increased hunting opportunity whereas the higher objective was intended to provide opportunity for hunters to harvest older and larger bucks." So now we have the DNR trying to justify reducing quality for more opportunity based on "data" but it has been in past proposals as well that it all about opportunity. Manage for an average age class harvested instead.

It was also mentioned that "limited entry" units would be managed at 25-30 buck to doe ratio. However, you have "limited entry" hunts on all general units. These hunts need to be eliminated, or permit numbers drastically reduced. Some consistency with regards to "limited entry" hunts should be considered.

With new units being made, I would like to see the "largest unit" in the state, the Manti, be reduced to a few smaller units. This would help to better manage several of your factors for health and Buck to doe ratios. It would help disperse hunters more across the landscape and allow for better management of the unit.

However, I beg you to implement a similar point restriction for adult hunters on the "Manti" unit as well, but with a minimum of 3x3 (not including eye guards) or better for adults. This is the largest unit with the most opportunity in the State. I feel that this unit should be managed a little bit more as hunters can congregate and typically hit certain areas more than others, thus affecting parts of the unit differently than others. That said, making adults work a little harder to harvest a 3x3 or better would be a rational restriction to help spread hunters across the unit a bit more evenly to harvest slightly older/bigger animals.

Additionally, as suggested in comment #4, how about putting a minimum of 3x3 or better (some units 4 point) restriction on all adults and then guarantee tags for all youth applicants.

I would also suggest restrictions on access roads as an option to challenge hunters a little more as well. In Colorado, they have "seasonal closures" and I think this could be used here in Utah in order to limit ease of access and make hunting a little more challenging without having to restrict weapons as much.

I am not a fan of antler point restrictions or primitive weapons only hunts. Most hunters want to use a rifle, yet we keep taking tags from rifle hunters and giving them to lower success methods in the name of increasing opportunity. Then we take the lower success methods and make them even lower success (limit power of scopes or remove scopes from muzzleloaders, etc.) while doing nothing to decrease success on the most successful method (long-range rifles). If we can change muzzleloader scopes to 1x, we can definitely limit scope power on regular rifles to 9x. I see people bragging online all the time about how they shot their deer or elk at 800 yards. That is not fair chase you a hunter is not making that shot without a 20x scope. If we are going to reduce success rates, let's be fair and reduce the success rates for everyone--not just those that already have limited success.

Antler point restrictions are a horrible idea! I saw a presentation from the division or somewhere showing that survival of buck from 1.5-2.5 years of age was about 50% and 2.5-3.5 was about 80%. If those numbers are accurate and it takes an average of 3 years for a buck to reach 4-pt in size, for every 100 yearlings on the landscape only 40 make it to 3 years old. Requiring a buck to be 4 pt or better to shoots squanders the other 60 bucks that were on the landscape as yearlings. Further, there will be tremendous pressure on the 4 pt genetics and no pressure on the 2 pt and 3 pt genetics. This seems like a horrible idea?? According to the survey, about 1/2 of people want opportunity and 1/2 want more quality (eyes of the beholder, but let's assume that means larger antlers even though I do not believe there can be higher quality that someone that is excited and happy to harvest/eat a yearling animal). We already have both in this state--we call them limited entry units and general season units. Please leave general units for opportunity and limited-entry units for "quality".

Can I ask a few questions and give some thoughts & feedback?

1)

In talking about population management and sustainable harvest, to say "how we hunt Bucks is not what drives our populations, but is what's happening with our populations is determining how we hunt bucks". So then, wouldn't you say that we have a lot to do with what's happening to our populations by how we hunt our bucks? When you look at your top down versus bottom up, wouldn't hunting greatly affect our top down effect on mule deer herds in management? Especially over the past 10 years we are averaging taking 25,000 animals off the landscape? To say that how we hunt bucks has nothing to do with what's happening to our population is absolutely ridiculous because this whole plan is off of managing our herds by how we hunt them.

2)

Can you please explain in terms of buck-doe ratios, how and justify when you say,

"Recent data suggests that managing at higher buck-to-doe ratios may be detrimental to deer populations", and then go on to say there are various reason why lower B-D ratios are beneficial to long term health for deer herds. Okay, so this works on the General units, so you say? So then, how are we managing for such quality and high buck numbers in limited entry units, specifically the top two? These premium units are after double or even triple of the regular b-d ratios? Then where is the concern for overall longterm health ??? If the higher ratios impact overall long term health and numbers then why the high objective? Or, if I favored the premium units, to say for a guide or outfitter, who relies on these units to produce quality animals every year. According to your statement, these units should be on a decline because of their high b-d ratios! That's not good! But evidence shows that these units continually produce quality animals year to year with high ratios. It seems a poor argument to make that's two sided and contradicts itself. You say one thing, but the way you manage these units say another.

3) In speaking of CWD, you focus a lot of your efforts on these general season units because they are where it has been found, but nothing is ever mentioned of the premium units? Are these units currently being monitored? Premium units are targeting for a higher age class animals, but yet your testing says the higher age class animals tend to transmit the disease more often. So we can try to lower the age on general season units, but maintain a higher age on the premium units? In an interview with Ginger Stout, episode 60 of the wildlife podcast, she mentions a few ideas of how this disease is transmitted, by about the 6 min 30 second mark she says that there is no exact mechanism of how they know how this diseases spread? The disease was first found in Utah by a positive test in 2002, but my question is, is when did we start testing for this disease and has it been here longer than that?

She also mentions that buck deer, specifically older class buck deer tend to carry this disease more than any other deer? With this be because this is the number the majority of the deer that you're testing? I would like to know if as many doe are being tested as bucks?

It seems another point to drive the narrative to maintain the general season units as "cash cow" units to allow as many hunters per field as possible while putting exponential efforts and resources in the premium units. I believe most hunters would like to see an equal playing field throughout the state, even if it was a sacrifice at their own home unit that they've hunted for generations.
