20 Bucks to Doe should be the baseline number to provide adequate breeding coverage of the does, synchronize the fawning births better, and provide better age class for the bucks before they're harvested. My time in the field this year, I've seen many fawns that appear to be undersized, which I attribute to late birthing dates since the moisture and feed appear to be good. I don't think the breeding coverage is adequate right now which is going to lead to unsynchronized births (late births), undersized fawns, and reduced overall fawn survival - the key to continue providing tags while maintaining age class and overall herd size. 20 bucks to doe is supported by the research as well. I think the buck to doe ratio needs to be 20-22. Also, I like breaking units up into smaller units and adding more season dates to reduce the density of hunters in the field at the same time. The congestion on the mountain is hard for hunting, camping, and stressing the deer out. I think more seasons, even if it extends the overall hunting year longer, will reduce the density on the mountian at any given time and actually reduce the stress on deer even though the overall dates will be longer.

In regards to the antler point restriction, I hunted Pine valley this year general deer Muzzleloader. I have to say I was very dissatisfied with the quality of deer on the unit. But adding further restrictions on an already restricted hunt (the deer hunt) is a terrible idea. If I had waited the three years to draw like I did this year and was not able to fill my tag because I did not see a 4 point in Pine valley I would be upset. I did not see a deer with more than 3 points on one side during my time hunting. I hunted every single day, and scouted a month in advance. Also how am I supposed to get my own children interested in hunting if I am not able to hunt a deer and harvest one with my children there? Restricting pine valley will also limit the hunting units available to us in Southern utah as well. Unlike northern utah we in southern utah have easy access to 2 units Zion and Pine valley. Also strongly disagree with the statement that it is taking 1-3 years to draw a deer tag. I have consistently been at the three year mark to draw a tag. Also my mother had to wait 4 years and same for my father to draw a tag. These numbers are ridiculous. How are we supposed to interest our children in hunting as well as hunt in the state of utah when you realistically look at it with the draw the way it is my own mother will only hunt a deer maybe 5-7 more times in her lifetime?

The hills are baren. we need to back off and allow numbers to recover. we have done so much damage in the past, its time we answer for this by limiting hunting and hunters. less tags, shut down units for study, create more safe habitats, etc...

CWD is not a disease only spread by bucks but you are trying to add that to the plate as if high buck counts are resposible. Does are to blame more than bucks. Does congregate far more than bucks, if CWD is going to be presented as a threat, we need to discuss total erradication. its a difficult task I understand but trying to contribute this issue to your "High buck to doe ratio" is disgusting.

at what point will the Division start talking about the impact of Livestock on government lands affecting carrying capacities? Livestock impacts carrying capacities far more than "High Buck to Doe" Counts. But were not talking about it?

I watched the video and read the entire management plan document. I'm passionate about deer, and I studied wildlife biology in school before changing degrees and going into education. I have also participated in the dedicated hunter program five different times.

First of all, I applaud you for tuning out some of the public comments on social media calling for tag cuts and a complete reset. Cutting tags does not grow more deer. I am in the opportunity camp. I would love the opportunity to hunt every year, even if the chances of success go down. There are big bucks on every unit if you are willing to put in the work. I see the drop to 15-17 bucks per 100 does as a great move that should increase my opportunities to hunt and increase deer available in the long run. All our conservation efforts should be on doe and fawn retention and you guys nail that in the video/plan.

I also agree with the habitat improvements and look forward to seeing 600,000 acres improved and the changes to prevent chronic wasting from spreading.

One concern I have is depredation hunts. We own 80 acres of alfalfa and have a few landowners on neighboring farms that shoot a lot of does on the Thousand Lake unit. That unit cannot handle having does harvested in the name of depredation. Is there not another way to compensate landowners for their losses? I think of all the money paid out at the hunting expo and can think of no better use than to buy the life of does on struggling units. Or simply issue them buck tags instead! Bucks don't impact the unit's population like a doe does. I know that the same thing happens on units throughout the state. Please try something else!

Predation seems to be a big issue on these units as well. I had a Fishlake bear tag in 2023 and hunted Thousand Lake. More than a dozen bears hit my bait sites, and I also got a few lions on the cameras during that time. More bear tags and some sort of Cougar bounty would help these units out immensely. There just aren't enough houndsmen willing to harvest lions for the sake of the deer herds.

I also feel that if we really want to increase opportunity, we should make people choose between limited-entry deer hunts and general season. Those who cry for tag cuts can apply for limited-entry units where the tags are cut and the buck-to-doe ratios are higher. They can then deal with the consequences by only drawing a tag once every decade or two. That would address the point creep issue on limited-entry units and make drawing a general season tag much easier.

I watched the video and read the entire management plan document. I'm passionate about deer, and I studied wildlife biology in school before changing degrees and going into education. I have also participated in the dedicated hunter program on the Boulder and Thousand Lake units five times.

I think it is great that you are being proactive and trying different things. I agree with you that the technology used in hunting has gotten out of control. I hear stories of 1,000+ yard shots all the time, sometimes even with a muzzleloader. To many, it is more about the shot than the hunt.

To me, the real head-scratcher is: Why the Boulder unit? I just finished my third year of the Dedicated Hunter program and spent 50+ days on the mountain. It is in better shape now than it has been in years, and your data corroborates that. It had 31 bucks per 100 does last year! That is limited entry status!!! It saw 25 per 100 over the last three years! I had dozens of opportunities to harvest 180" class deer.

As I understand it, weapon restrictions are in place to make it more challenging to take a deer, thus increasing the buck-to-doe ratio. It seems that you need to increase tags drastically on the Boulder to bring the ratio back to the 15-17 bucks per doe ratio you are proposing. So why the weapons restrictions?

I totally understand trying something on Thousand Lake. That mountain is an absolute dumpster fire right now. I'm not sure how you found 100 does to figure out the buck-to-doe ratio (unless they migrated onto it after the hunts were over). I killed a few giant bucks on there after it switched from Limited Entry to General season, and I love the mountain more than any. It is the mountain my family hunted on for generations. Try the weapon restrictions there, but please don't convert it to Limited Entry again!!! No one is applying for the archery and muzzleloader permits as they are!

I am also not a fan of Antler Point restrictions in any form. They have been tested before and failed miserably. It increases pressure on the mature bucks, increases illegal harvest, promotes poor genetics, and frustrates hunters. When combined with weapon restrictions, it would be an absolute train wreck! You would need a scope on your gun to be absolutely sure you had a 4-point in your sights.

I wish this was two sections because I'm in favor of the youth changes, but hate the Dedicated Hunter changes.

I am 100% in favor of giving the youth the opportunity to hunt. I think they should draw any general tag they put in for their first year automatically and have improved odds after that. Thanks for making these changes so it is more accessible to them.

I'm all about having the opportunity to hunt. I feel having a tag every 3-4 years has hurt the hunting tradition in my family (we live and hunt in the Boulder/Thousand Lake Units). We always apply for hunts that give us the best odds to draw a permit (archery/muzzleoader). I have drawn for Dedicated Hunter 5 times now and was amongst the first cohort. While I understand why you are closing the ability to apply for both, I feel it punishes those who will do anything to hunt deer. On the Boulder, it took 4 points to draw a DH permit. Who is going to wait for 4 years, pay extra money, and complete 16 service hours just to shoot a couple of deer? I would predict that most will bail for the GS hunts. Even if they do stay, you only take 300 hunters out of the GS pool, so the draw odds do not get that much better. The only people applying for both DH and GS are your most avid hunters, and you are punishing them for doing whatever it takes to hunt deer.

There have also been years when we applied for Dedicated Hunter, and there weren't even any tags available (Boulder 2020)! In the following few years, only 1 or 3 permits were available. I know you fixed it so we can see the permit numbers before we apply, but not everyone looks at that and can be tricked into applying for something that they will never draw.

If you really want to increase opportunity, we should make people choose between limited-entry deer hunts and general season. Those who cry for tag cuts and bigger bucks can apply for limited-entry units where the tags are cut with higher buck-to-doe ratios. They can then deal with the consequences of only drawing a tag once every decade or two. That would address the point creep issue on limited-entry and general units.

Good work DWR. I appreciate your efforts. As a part of the plan I would like to see a program or employee to assist private landowners to get assistance with fencing issues. I bought 5 acres in a central Utah town a couple years ago. The prior owner installed fencing. The fence caught/killed 3 does over a 2 year period after my purchase. I spoke with the prior owner who told me had killed 1 or 2 deer a year (this means maybe 10 deer in 6/7 years). I would have loved someone from the DWR to visit my property and help me with a solution other than just removing the fence. I've now removed a section of the fence, but I don't know if this will be effective, or whether there are other options. I imagine that if there were an employee dedicated to this issue (helping private landowners with fencing solutions) that we'd be preserving population while essentially opening up more habitat on private land.

I have been been in the Dedicated Hunter program since its inception. I have hunted the same area in the Cache Unit for over 46 years. I have been extremely satisfied with deer hunting. Last year hunters were required to pull magnifying scopes off of muzzleloaders. This change cost \$500 for a new sight system. Under this new proposal I will have to scrap my current muzzleloader and invest \$500 to \$600 for a muzzleloader that fits the restricted muzzleloader definition.

We will also be required to remove our scopes off our rifles. "If only our rifles had iron sights", so back to the store to purchase a rifle with iron sights. Another six to nine hundred dollars. This research study could cost each hunter a minimum of \$1,200 if they are in the Dedicated Hunter program or \$500 to \$900 if they draw muzzleloader or rifle tag.

The Cache unit currently has around 200 Dedicated Hunters. Each hunter completes 32 hours or they buy their hours at \$40 per hour. If half of the dedicated hunters drop out due to the new equipment requirements, it could be a loss of 3,200 volunteer hours. Will other sportsman's organizations step up to complete the volunteer hours? Will habitat projects on the Cache unit not be completed?

What is the purpose of this proposal? Is it to increase the number of licenses sales or is it to increase the number of bucks?

The Cache unit currently has 17 bucks per 100 doe's post season. Objective is 15 to17 bucks per 100 doe's post season. The Cache unit is very weather dependent. When we have a hard winter we lose our deer. If we have more bucks than objective, it takes longer for the deer herds to rebound from winter loss. The bucks out-compete the doe's for survival, reducing the reproduction and survival of fawns.

Next year I will be 62 and my eyesight is declining. I depend on a scope to insure I make a humane harvest. Open sights including a peep sight with a globe front sight has made precision shot almost guess work. I can't imagine a new hunter using open sights when the hunter education course allows them to use scopes to pass their shooting proficiency test.

Lets wait until the data is collected from this years hunt before significant changes are made impacting the 4,000 plus hunters that hunt the Cache unit.

This proposal doesn't do anything for habitat that will sustain deer numbers.

By your own statistics you have brought the Beaver unit from awful buck/doe ratios, to now for the last 2 years around 20 bucks per 100 doe. Because of this you increased tags by 600 on this unit. Why in the world would you want to go backward? In a time when buck number confidence is already low and hunters not seeing the buck numbers you indicate, it seems very counter productive to now say you are lowering that number. By moving backward, you have just confirmed to the hunter that the numbers you put forth were not correct. Your own post season stats show that you can obtain this number and also increase tag numbers. If the deer were over crowded and fighting for food to survive that is one thing, but this is not the case. Having a couple more bucks per hundred doe on the landscape is not going to affect the other deer, there is just no justification for decreasing this number. If you change the hunting restrictions to open sights on the Beaver, you can increase tag numbers anyway. No need to try and reduce the number of bucks, when your choice of weapons will only increase the buck number, because hunter success will decrease. There is NO need to change the buck/doe ratio.

Junction Valley with 2023 Harvest Data shows that 0 bull elk were harvested and that satisfaction was a 3.0 which is low if you compare it to other CWMU's. 2022 they have a 60% harvest rate, 2021 they have a 60% harvest rate, 2020 they have a 40% harvest rate, 2019 they have a 60% harvest rate. I want to start by apologize about the length of this one. But I really hope you'll read through it all and consider some of these points. I really don't like only having restricted weapons hunts on any units. I think this will just force a lot of those applicants to other surrounding units and increase point creep there. I think there is a small demand for this type of hunt but I don't think it should be restricting other weapon types. I strongly oppose restricting Pine Valley unit to a 4 point or better. There have been multiply states do this same study even on 4 points and none of them have come out in favor of the mule deer heard. All this will do is create buck to doe ratio increase that will not be manageable. According to the classification data from the last 2 years only 19% of the bucks classified post season had 4 points or more. That means last year there would only be roughly 600 bucks that would even be legal and there would have been 2700 adult hunters for just 600 bucks that are legal. Even after a year or 2 there will still be around 50% of the bucks that will not be legal each year. This would create a giant spike in buck to doe ratios that I believe will be unmanageable. Which in turn would require a massive spike in tag increases over the years. I think this would lead to a dramatic increase in tags every year due to the plans objective being at 18-20 B/D ratio and with a restriction on legal bucks the division will not be able to manage for that ratio and it will always be over objective which in turn will increase tags every year. I am strongly against this management strategy. Although it will have it benefits by the end of the 4 year study if the division increase tags 30% for the first 2 years until there is enough bucks in that legal category to increase some harvest and even 5% on years there after. I predict Pine Valley will see tag numbers exceed 6000 tags because of the buck to doe ration always coming in higher then the objective. I am also very opposed to implementing a weapons and point restriction study and not restricting it to only being eligible in a draw system. I think you will see the perception of a unit that is only 4 point or better and it will draw a lot of life time license hunters to that unit. I think any unit involved in this study should be declassified as a general unit during that time frame and should be by draw only and if a life time license hunter wants to hunt that unit they should have to draw it same as anyone else. Pine Valley is already one of the most sought after units of life time license holders. This will only make the demand even higher.

I have 50 years of participating in mule deer management from about every angle including many different wildlife conservation groups and even being a Southern Region Rac member and even eventually chairman of the Utah Wildlife Board. I have done a lot of work and hands-on studies with numerous DWR employees and biologists. I have lived through the the glory days of mule deer in Utah to the extremely low deer numbers of the present.

It is my view that we have been managing deer herds based on bucks. we have tried almost all the buck- hunting stratagies that a person can imagine and all the time our deer numbers continue to decline. The average sportsman just can't seem to grasp the idea that in the scope of a deer herd bucks are a very minor piece of the pie compared to doe and fawn survival and reproduction.

Back in the glory days, we had deer units that had over a hundred fawns per hundred does on post-season counts. now we have units down in the low forties and probably high thirties. On most units, it takes about 65 to 75 fawns per hundred does to just maintain.

If I could wave a magic a magic wand, I would turn this whole management plan around and get all the vested and interested parties together and list all the ideas that people think would help raise the fawn birth and survival. A lot of these ideas wouldn't be possible to do. Freeways and public growth is here to stay, 1080 poison will never be allowed again but even with a lot of these issues there are ways to improve fawn survival we would just have to do the best we can with the sideboards that we can't change.

Let's quit fighting over scopes on muzzleloaders, shortened hunts, antler restrictions, buck to doe ratios, season changes and all the other ideas that haven't done anything to improve deer numbers in the last 50 years in Utah. We will never have deer in the abundance that we had in the sixties but we can have way better herds in the future than we have today.

Let's manage for fawn survival first and bucks secondly.

I am having a really hard time understanding the reasoning behind the proposed weapon restrictions on the Boulder and other units. What is the end goal of the restrictions? To potentially give more opportunity by reducing buck harvest? Or, to create more mature bucks? The restrictions reek of a way for the state to create another "trophy" unit without coming right out and saying it. My question is how will this proposal help more fawns survive and be recruited into the herd? I have heard time and again from biologists from state to state express concern that high buck/doe ratios can potentially have a negative impact on fawn survival. If these units are "struggling", why are we creating a weapons restriction that could potentially save more bucks and put fawn recruitment at further peril? If we are trying to find a way to move more hunters through the points system, why don't we eliminate the opportunity for hunters to put in for both limited entry deer hunts and general season deer hunts? The proposal to not allow applicants to put in for both designated hunter and general season hunts is a good one....why don't we take it one step further and force hunters to pick either general season deer hunts or limited entry hunts? This would really show the DWR what hunters in Utah really want as far as deer hunting is concerned--more opportunity or more quality--and help move people through both the general season and limited entry points pools. With all that being said, I do agree with the idea of reducing buck/doe ratios on most general season units IF tag numbers can be increased as a result. What I am skeptical about is whether or not the Wildlife Board will allow tag increases even when buck/doe ratios are exceeded. Overall, though, I am not in favor of any of the weapon restrictions ideas and feel like it could be the nail in both my and my kids' hunting future. I have traditionally hunted the Boulder unit and if the proposal passes, I will be forced to by two new guns (IF I continue looking to be a designated hunter) which I cannot afford. So, my option is to hunt a different unit without the proposed weapon restrictions but that means hunting with the rest of my family--brothers and cousins--won't happen. I think increasing that management plan by even one year may tie the DWR's hands in the event a major change would want to be implemented. I would like to commend the DWR on their effort for the scale and diversity of the Mule Deer Committee they put together. Super great to see that amount of interests involved in this process. Really great points made about the heavier concentration and focus to predator management addressed in this plan. Serious issue that I think gives the DWR a lot more range of freedom to help mitigate loss from predators. The Bottom-up management plan implementations into this plan are phenomenal outline as well. The Watershed Restoration Initiative is a great plan. Really excited to see how that plays out. The 30% +- tag allocation adjustment freedom I think is a great addition to this plan but I think it goes counter intuitively with the proposed buck to doe ratios. Hunters are wanting more quality bucks on the landscape. We can't do that with fewer buck to doe ratios. These two plan proposals need to go hand in hand. Meaning, if we're going to cut tag allocations to help improve buck quality, we need to also raise our buck to doe ratios. We need more bucks making it through the hunting season and be able to reach higher age classes and more maturity. Disease resilience pertaining to CWD is a difficult thing to try to predict. Yes, CWD has began to show some prevalence in certain locations in Utah. And if the DWR was serious about CWD spread, I think we should be taking drastic steps to mitigate the threat of widespread transmission in stead of just cutting buck to doe ratios (still deer on the landscape besides bucks that will spread the disease, look at Michigan, Wisconsin, etc.). I would have to disagree with the first graph presented. It's only attempting to correlate precipitation, buck to doe ratios, and population growth. It completely neglects the affects of predation, fawn recruitment and survival, and habitat quality on population growth. But if you assume poor habitat quality (feed on the landscape) and also managing for more bucks on the landscape, I can see how a higher buck to doe ratio could negatively affect overall population growth. I'll say this, if I'm wrong here in my assumptions, I'd be more than happy to be better educated on the topic. I'll say I'm fairly split on dropping buck to doe ratios on most units across the state. With a demand from hunters called out for better quality bucks but with a main focus on growing populations in this plan it is difficult to see the purpose of dropping buck to doe ratios which doesn't correlate to better buck quality but does however provide more opportunity...potentially and from their data, show it should help assist population growth get going. Overall, I think this plan is a phenomenal step forward in addressing the major concerns for our deer in UT. Addressing population growth, predator management, and habitat. Looking aside from the "how we hunt bucks" portion and buck to doe ratios that I have some reservations/concerns about personally, I would completely urge the Southern RAC to push this through as proposed and let's see how our predictions do and make the proper adjustments moving forward from this. With the Mule Deer Committee and the DWR, I think this is a tremendous job at being honest about the state of deer in UT and how

do we make it better.

First off, I just want to say the I commend the DWR for coming forward with this proposal, I'm sure that it wasn't an easy decision to make and what to move forward with. Also, just want to note that I am no biologist and nor would I ever attempt to present myself as one. Just want to be an informed, educated, and involved hunter. Secondly, I myself, am not the biggest deer hunter, more of an elk man myself, but as a hunter I want to see healthy and strong populations of all game species across the landscape.

I just first want to point out the paper published by Wyoming Game and Fish Department "A Critical Review of Mule Deer Antler Point Regulations, Application, and Effectiveness". This paper outlines the previous attempts at antler point restrictions in Utah and their ineffectiveness, APRs in numerous other states, and other management strategies like this to try to improve buck quality. The results showed "significant illegal harvest of yearling males, reduced total harvest, reduced hunter participation, shifting hunter distribution to areas without APR, and a reduction in harvestable mature bucks". We've tried them before in this state and abandoned this method because of its short term efficacy and gains only. This does not impact buck quality and deer populations long term. These methods only show a delay in the harvest of certain age classes of bucks and with the ever present potential of harvesting younger bucks with faster antler growth. As well as the illegal harvest of non-qualifying younger bucks who do not meet the antler point restriction. I think what you're going to see if you impose this study on these units is a drastic drop in hunter participation in these units. Most hunters are not going to want to hunt these units with these new restrictions, especially on the Pine Valley unit and you will see a major influx of applications for other units across the state because hunters won't want to be a part of this. You have to think that there will be a large portion of the applying public that come application time, will be their first look at these new restrictions because of this study. And if implemented, once they see these new restrictions, they're going to apply elsewhere in the state because they will not take these new restrictions lightly. Probably feel betrayed and upset with the DWR for imposing new restrictions on the places they want to hunt because unfortunately they won't be educated on the study. This will greatly skew data results from this test because you won't have the test control variable of keeping the same average amount of hunters on the landscape for these units. If you want to consider making a change for buck quality. I think tag allocation cuts are needing more serious considerations. We need to focus on population growth and stabilization towards population objectives before we spend the time, money, and effort on a research study to study the minute effects of these proposals on buck quality. The only way to put more bucks on the landscape is through healthy doe populations producing deer and reducing our harvest of bucks until we can create stable age classes of deer that can reach maturity. I don't think this study aligns with the mule deer committee's top priority to grow more mule deer. Dax discussed in his presentation how buck hunting does not affect mule deer populations but how mule deer populations affect how we CAN hunt bucks and with the main priority to grow more deer, this research study doesn't show any purpose on how it fits in with that main

objective. Especially with historical data showing these restrictions are ineffective at long term buck quality improvement and hunter satisfaction and opportunity. With a new mule deer plan and a proposed research study, it's trying to change a lot of variables all at once. These proposed amendments are shortsighted for short term goals. I understand the DWR has an obligation to provide as much opportunity as possible and the best quality they can but they first have an obligation to steward the resource for all Utahn's that is held in trust by the state. The first pillar of the North American Model of Wildlife Conservation. You first have a responsibility to ensure the resources viability before you concern yourself with the obligation of providing opportunity and quality opportunity at that. Opportunity is not guaranteed but the resource in perpetuity should be.

Just want to close with saying thank you for taking the time to read this. I understand that this was quite lengthy and maybe a little long winded. And just want to reiterate that I don't want this to sound like a bash against our DWR. I think they are one of the best, if not the best, in the country about being as active and proactive as they can in management efforts and the RAC process is an amazing thing. I think the whole division, biologists and all are doing the best the can but I don't think this is the time or any time in the near future for this study.

I want to be clear on my stance of the Beaver West unit weapon proposal before my comments are taken into consideration for current dedicated hunter tag holders. I like the new approach to better help our deer herds. I think a weapon restriction is a good idea to study the impacts of modern technology on deer populations. I believe it will help increase the deer population, but the true results will be discovered at the conclusion of the study. I think it's worth a try. My only concern is the dilemma it puts current dedicated hunter tag holders in.

This year I drew a Beaver dedicated hunter tag. I put in for this tag to exclusively hunt the west side of the unit with non-restricted weapon rules. I have only 4 hours left before I complete the full three year hour commitment. I do not hunt the east side of the unit very much. The restricted weapon change will impact my time and commitment I have already put forth thus far. I do not want to have my dedicated hunter tag roll over to the east side of the Beaver unit. I also don't want to hunt with restricted weapons on the west side. I propose the following options for current dedicated tag holders:

- 1. Choose between the east and west side of the unit to continue on your current dedicated hunter cycle.
- 2. Have your bonus points reinstated to what they were before you drew the current dedicated hunter tag. If this option is chosen, the hunter must agree to having a 1 year restriction on your ability to put back in for the Beaver east or west unit for a dedicated hunter tag.

The survey results showed that people are willing to wait a few years to draw a tag for better deer hunting. By better deer hunting is seeing good deer numbers and the ability to see some mature bucks. So I don't understand completely ignoring the survey by lowering buck to doe ratios and increasing opportunity by giving out a potential 20,000 permit increase!

I also think out of all the things that impact and play a role in mule deer survival the DWR is deciding to to put all the eggs into the basket of bucks numbers are the biggest threat to survival. Is it a contributing factor, yes, however very small factor, and limited to our limited and premium limited entry units. This is not a problem on general season units. I have heard DWR managers as well BYU professors all say on different podcast that it doesn't start to affect populations until you start approaching the high 20's to 30 bucks per hundred does. We don't have a unit in the Southern Region that is close to that, and we have been at 18-20 bucks per hundred does the last few years and have had adult and fawn survivals in the 80 and 90 percent's. The sacred graph that is being used to portray this model has points where buck to doe units are in the 40 plus category. Yes that is a limiting factor in those units and have always seen minimal to stable growth. If you take those extremes off of the chart and strictly used our general season units I would be willing to bet you wouldn't see a separation in the two lines until you approached the 22+ buck to doe ratio. The last time we saw extreme growth in our deer herds the buck to doe ratios in the Southern Region we are the 18-20 levels and we grew deer by the thousands on these units. It is vehicle collisions, predators, and most importantly drought that have caused the decline in deer numbers resulting in less bucks on the landscapes and frustrating hunters to the point we are now.

I also have a SIGNIFICANT issue with the 30% increase and decrease a biologist can do annually with permit numbers on a unit without taking it through the public process! The RAC and Board public process is the way it has been mandated to make changes to any wildlife related issues in this State. Allowing this change is the same as allowing selfish unregulated politicians to make changes to wildlife management circumventing the public process! This is something that absolutely should not be allowed. I am sorry that the public process is long, exhausting, often frustrating, and mentally demanding for managers, biologists and even RAC and Board members, but it is the mandated process that has to take place. As a RAC this should offend you and could be start to many others rules that could take place without the opportunity for the public to voice support, concern or insert new ideas to the process. A biologist could literally increase or decrease permits in only a few years time and nothing could be done as long as they only did 29% a year! Every biologist and manager should have to stand if asked to justify their recommendations and the changes they are making. This is the people of the State of Utah's wildlife and you have been tasked to manage it not rule over it.

Also you are reducing the age on LE and PLE deer unit buck to doe ratios reducing the buck to doe ratios by 5 on the top end each and there is no mention that this is a change to the previous plan, I feel like this is just a hope to sneak by, that should be mentioned. These aren't general units, and are meant to be managed at high buck to doe ratios, leave it that way!

Also there needs to be a way for general season deer tags that have been surrendered to be returned to the public. Either a weekly sale like Colorado or a random tag released to a website like Nevada on a first come first served list. I'd bet 1000's of general season deer tags get surrendered every year and never get returned to a hunter. Get them back into hunters hands. This is a major opportunity that is not being used. Let them all go to youth even, I don't care just get them back out. Make guys use/loose points to get them, the DWR makes more money, and we move guys through the point system by getting a deer tag into someone's hands.

- 1. Success rates are going to drop significantly because most hunters won't be able to find a 4+ point buck.
- 2. At the end of the season, the buck-to-doe ratios are going to be very high because nobody was able to kill 2 and 3 point bucks (yes, I know youth hunters can kill anything but I doubt they'll make a big impact). After year 1 I wouldn't be surprised if the buck-to-doe ratios are over 30 bucks per 100 does because of the high number of small bucks.
- 3. You guys will have to increase tag numbers every single year because the buck-to-doe ratios will keep getting higher and higher because of the lack of 2 and 3 points getting killed.
- 4. I'm guessing that within a few years the tag numbers will probably double (6,000+??) to get more people in the field to kill the 4+ point bucks. Overcrowding is going to be a huge issue and most hunters will be very dissatisfied with their experience.

I feel like all the 4 point antler point restriction is going to do is cause a huge increase in tag numbers because of the low success rates.

IF you are going to do an antler point restriction, do a 3+ point restriction. At least that way the harvest success rates will be higher, more hunters will be happy, overcrowding/tag number increases won't be as bad, and all of the 2 point bucks can survive another year.

This is never mentioned in the presentation as a change? These are LE entry units and are by design managed for trophy quality and a higher buck to doe ratio. Looking at Utah's LE Deer points reports there are tens of thousands of people willing to wait for a LE deer tag. When hunters draw these permits they are looking for a quality experience. Let's leave them be.

I'm against the proposal to reduce the buck to doe ratios on Gen units. This is only so more permits can be offered to the public. I'm all for issuing more tags but lets do this once we have the deer numbers on these general units to support the higher permit numbers. The survey sent out by the mule deer committee showed that hunters are willing to wait years for general tags if their experience will be better with higher success. Even Dax said on a recent podcast that "lowering the buck to doe ratios will lead to lower the success rates, Fewer older age class bucks and overall fewer bucks on the landscape." This doesn't sound like a great experience for most hunters.

Utah should look at a way to reallocate returned general season deer tags. If they are wanting to kill more deer by issuing permits, they should get these already approved permits that have been returned to the state in hunters hands. I'm sure there are several hundred if not thousands of general season permits returned to the state each year that go unused. There are many ways of doing this, like an online sale once a week similar to Colorado or a first come first serve process like Nevada put in place a few years ago. If a hunter chooses to buy one of these permits it should cost them their general season preference points.

I understand my past conviction may raise concerns in connection with the operation of a CWMU. Despite these potential concerns and the initial recommendation of denial from the Department of Wildlife Sources, I believe that my experience, knowledge, and commitment to wildlife conservation make me a suitable candidate for this role.

I recently purchased the property known as JB Ranch on or about

I recently purchased the property known as JB Ranch on or about September 30, 2024, which I currently operate as a CWMU, but which status expires January 31, 2025. As the new owner of JB Ranch, I am passionate about continuing its legacy of providing exceptional hunting opportunities for the public, and I recognize the importance of maintaining the ranch's high standards and adhering to all rules and regulations applicable to CWMUs.

The Council's recommendation for approval of JB Ranch's application of renewal for CWMU is in the best interest of the public, and I will be an exceptional partner and operator of JB Ranch as a CWMU, for at least the following reasons:

- Extensive Operator Experience: My 40-year career in the ranching industry, both as an operator of the historic, high fenced hunting ranch known as Circle E Ranch in Grimes County, Texas and the Canada del Oso (Canyon of the Bear) Ranch in Mora County, New Mexico, has provided me with invaluable knowledge and skills in wildlife management. During this time, I bought and sold thousands of animals all over the United States and I maintained the largest elk herd in the State of Texas for many years.
- Dedication to Ethical Behavior and Community Involvement Following Prior Conviction: In 2006, I was arrested and charged with smuggling white-tailed buck deer from Minnesota to Circle E Ranch in Grimes County, Texas. Shortly thereafter, I served eighteen months in federal prison, followed by a three-year probationary period. I acknowledge the serious nature of my past actions and the consequences I faced. That experience has profoundly humbled me, shaped my perspective on life, and made me a more grateful person. I have learned from my mistakes and have dedicated myself to living a responsible and law-abiding life. Since my conviction, I have demonstrated a strong commitment to ethical behavior and community involvement. I have donated many hunting opportunities to Make-A-Wish Foundation, to various church groups, to kids, and to veteran groups, and I plan to continue to make such donations for hunting opportunities on JB Ranch.
- Public Access: I am committed to providing public access to JB Ranch, including the campground and guided hunting opportunities. Currently, JB Ranch receives the following for the public: two buck deer tags, two bull elk tags, and twenty-one antlerless/cow tags. I hope to continue to provide hunting opportunities to the public through CWMU.
- Commitment to Conservation and Ethical Hunting Practices: As a lifelong hunter who harbors a deep appreciation for the outdoors and nature, I am committed to preserving wildlife populations and their habitats. I believe

that a well-managed CWMU can balance hunting opportunities with conservation goals. I promise to strictly adhere to all hunting regulations and promote fair-chase principles.

- Collaboration with DWR and State Agencies: After I served my sentence, I received no violations from any governmental authority in the states of Texas or New Mexico during my time as the operator of Circle E Ranch and Canada del Oso Ranch because I am committed to following applicable rules and regulations to these activities. When I first purchased JB Ranch, I believed cameras, feed stations and blinds would have been suitable for the ranch, as was the case with my prior operation of my prior ranches. However, I have since educated myself on why I was mistaken. I will cooperate fully with the Department of Wildlife Resources and other relevant government agencies, officials and employees to ensure the long-term sustainability of JB Ranch and the CWMU. I am committed and I pledge that we will not feed or put out mineral blocks except as may be permitted under applicable rules and regulations.
- Future Plans: I care deeply about JB Ranch. I plan to implement multiple initiatives to enhance the ranch's wildlife habitat, including planting additional forage and conducting controlled burns, all within the applicable rules and regulations and with the cooperation of, and counsel from, the Department of Wildlife Resources and other applicable governmental authorities. Additionally, I wish to surrender and waive approximately 50% of the number of harvested bucks to allow for larger antler growth, which would give the public a chance at larger mature deer in a much older age bracket.

As the Council well knows, JB Ranch is a pillar in the CWMU program. I am eager to apply my knowledge and experience to the management of JB Ranch as a CWMU. I am committed to maintaining the ranch's high standards, adhering to all CWMU rules and regulations, and promoting ethical hunting practices. I believe that JB Ranch can continue to be a valuable asset to the community and a model for wildlife conservation, as it has been for decades.

I respectfully request that the Council recommend approval of JB Ranch's application for renewal of CWMU status to the Wildlife Board. I believe that this decision would be in the best interest of both the ranch and the State of Utah.

I just want to say that I am excited about the muzzleloader restriction part of the study proposal but not so much for the general rifle restrictions. For most of my adult life I have hunted the Cache general rifle deer hunt with a traditional muzzleloader. I do have modern rifles that I have used but my heart lies in traditional black powder hunting so I have most often then not carried a muzzleloader on both the muzzleloader hunt and the general rifle. That being said I could be selfish and say that I am in support of this study but most of the people I know are against it. They don't own rifles with open sights nor can they buy one with open sights because they are few and far between. I am not against the research, I just don't think it's feasible for all the cache hunters to adapt to it. I have hunted the north Cache with open sights for a long time and will stress that it is extremely hard to hunt during the rifle hunt. The deer are in the steep transitional ranges as they move out of the high country on their way down to the winter range foothills. That country is not conducive to short range weapons. I honestly didn't think it would pass the northern RAC. After watching both the northern and central RACs I was blown away at the disregard for the public opinion from the surveys. I hope that when the other RACs vote they will think about what impediment this will be for hunters on the cache. Lots won't be able to go because they won't have a legal weapon to take. Like I said, I could be very selfish and say that I am all for this but I can't in good conscience say that I am. I understand the proposal uses the restricted rifle definition but there has to be halfway point where they can at least use a red dot or non magnifying scope rather than having to buy a new rifle or have their current rifles tapped for sights. I do appreciate all the work everyone of you puts into our wildlife and our hunting opportunities I just felt the need to express my feelings on this topic. Thanks you.
